12. Key qualifications (relevant to the programme):

? **Village Production Systems:** Directly involved in the conceiving, implementation and monitoring of holistic / integrated livelihood programmes covering village production systems. These have covered farm-based production, livestock based production and tree-based farming systems. The work has covered effective design and implementation as well as backward and forward linkages, and training and capacity building.

? **Rural Agribusiness and Marketing:** Worked through various programmes on introducing appropriate interventions to help producers move up the value chain. This has taken the shape of a programme to develop rural agri-business in the form of cooperative based post-harvest operations as well as small agri-business units by individual entrepreneurs. The areas covered are marketing of fresh mangoes and its supply chain management, processing of raw mangoes into pickles through decentralised processing units, processing of mangoes into pulp and processing of cashew nuts. The agri-business development has also been in the backward linkages for the production of farm inputs like vermicompost and organising farm-input supply operations.

? **Project Financing and Financial Management:** Have directly managed various development projects covering: conceiving and developing project proposals for various sponsors, coordinating project implementation and monitoring projects through physical and financial monitoring, variance analysis and conducting project reviews. An indicative list of various projects handled appears further below.

? **Public Private Partnership:** Associated with various projects taken up in collaboration with private corporates: these range from greening of premises and promoting Natural Resource Management to various CSR interventions. Was invited to participate as a panelist in the 5th International Sustainability Forum held at Zurich in August 2004. The theme for the Forum was Business Investment in Development.

? **Institution Building:** Directly involved in the institutional development of BAIF Development Research Foundation from a primarily single sector organization to a multi-sectoral development organization with a number of interdisciplinary programmes.

Handled as the Project Leader, the Institutional Support from IDRC, Canada to BAIF, which enabled BAIF to put in place a multi-sectoral applied development research programme, and initiate work in new directions. The programme was jointly sponsored by CIDA and IDRC.

Helped in the establishment and nurturing of two important institutions within the BAIF family of organizations: (1) The Dr. Manibhai Desai Management Training Center (MDMTC), which is involved in knowledge-building and capacity-building for the development sector, and (2) DHRUVA, which is involved in developing innovative approaches to tribal development, focusing on livelihoods and improved quality of life.

Initiated and followed through the process of Strategic Planning for BAIF and its associated organizations.

Directly involved in the institutional development of BAIF as a Resource Institution in the areas of Watershed Development, Tribal Livelihoods and Processing of farm produce, particularly mango, cashew and other fruit and nuts.

- ? **Natural Resource Management and Livelihoods:** Initiated the Watershed Development Programme in BAIF through an applied research project for the Conjunctive Use of Ground and Surface Water Resources in the Deccan Trap areas of Maharashtra. The watershed development programme in BAIF now covers over 0.4 Million hectares in six States of India.
